At this time, both Congressman Mark Amodei and Patricia Ackerman have confirmed their participation.

AAUW Governance Committee Survey of AAUW State Presidents

The AAUW Governance Committee conducted a survey of AAUW State Presidents in mid-June asking for input on two questions. Caroline Punches, our AAUW Nevada State President, contacted our branch presidents, and, in turn, shared their insights with the Governance Committee. The two questions were:

- What is it about our current affiliate structure that is impeding the ability of branches (and state organizations) to implement the AAUW mission?
- Can you share examples of branches in your state that are using simplified or nontraditional models of governance?

As the Governance Committee noted in their summary report, "The responses were very informative and their diversity reflected the range of branch sizes and the diversity of the 31 States represented. All Branches are trying to find creative solutions to supporting the AAUW mission with our declining and aging membership. Many states face unique challenges of geography, political orientation and demographics." They further stated that the purpose of the summary report is simply to keep state presidents up to date on the input received. Implementation of any suggestions would be part of a process.

The four-page summary report will be shared with our Executive Council as well as Branch presidents. The report contains a lot of suggestions as well as concerns. We are sure this report will be most helpful as the Governance Committee looks at AAUW's Organizational Structure and membership requirements.





School Board Candidate & Regent Candidate Conversations

Sondra Cosgrove, President League of Women Voters of Nevada, Nancy Scott, President League of Women Voters of Northern Nevada and Caroline Punches, President, AAUW of Nevada met with several school board candidates from Clark and Washoe Counties, Carson City, Nevada State Board of Education, as well as for the regent candidates for NSHE.

These conversations were conducted via Zoom. Each conversation was approximately 45 minutes in length. The recorded conversations are available on the LWV blog.

Each candidate was asked to respond to four questions:

- 1. Opting to have elected officials manage education necessarily produces governance by individuals with a wide variety of backgrounds. How does your background make you a good fit for education governance?
- 2. For the second time in ten years, albeit for vastly different reasons, education budgets have been drastically cut. How will you include all stakeholders in decisions on cuts to services and projects, while also ensuring equity is prioritized?
- 3. What outcomes should public education in Nevada produce to treat every student equitably?
- 4. What are your views on education funding in Nevada?

PUBLIC POLICY By Debbie Nicholas

So much is happening (and has happened) on our national and local fronts over the next few months. There are several articles on the AAUW.org website which have compelling information about the pandemic and its effects on women.

Women suffer distortional effects of the economic downturn caused by the pandemic as they are more likely to be working in *essential worker* fields, are more likely to be in part-time positions, or in positions lacking health and retirement benefits. Women are disproportionately impacted by the closure of schools and childcare.

NEVADA COALITION FOR WOMEN'S EQUITY 2020 CANDIDATE SURVEY RESPONSES

For those who are not familiar with the Nevada Coalition for Women's Equity (NCWE), it is an alliance of organizations that was formed in 2015 with an AAUW impact grant. The members believe women should be treated with impartiality, free from harassment and abuse. We are working to make a significant impact in the lives of women and their families in Nevada. The members are: AAUW Nevada, League of Women Voters of Nevada, Make It Work Nevada, National Association for the Advancement of Colored People (NAACP), Nevada Advocates for Planned Parenthood Affiliates, Nevada Coalition to End Domestic and Sexual Violence, Nevada Women's Lobby, Progressive Leadership Alliance of Nevada (PLAN), UNR Committee on the Status of Women, and Women of Washoe-WOW, a chapter of Alliance for Retired Americans.

In contrast to previous election cycles, the NCWE team expanded its 2020 Nevada Assembly and Senate Survey so that candidates could elaborate on their positions on issues of importance to the coalition.

All Nevada State Assembly and Senate candidates were contacted multiple times seeking their response to NCWE's survey on issues affecting Nevada's women and families. If you do not see a candidate's response, they either elected not to respond or they responded well after the August 3rd extended deadline. See the responses at


