President's Message:

Greetings AAUW Nevada Members! It's 2024 and what a year we have ahead of us! It is going to be a year of elections! For us as individuals, as registered voters in Nevada and as AAUW members!

NV Presidential Primary: As I am writing this, Nevada is conducting its first ever "official" Presidential Primary! Registered Republican and Democratic voters can vote in person or by mail in this primary. The Republican party has opted to have an in-person caucus on February 8th and has let registered voters know that delegates to their National Convention will be selected through the caucus process only. Republican registered voters will also receive a primary ballot in the mail, but that ballot will not include Trump. AAUW Nevada really appreciated Sondra Cosgrove's Zoom meeting on January 12th explaining the process(es) in detail.

AAUW National Election - Bylaws Update: Every AAUW member will have the option to vote to eliminate the educational requirement for becoming a member. Ballots will be sent via email from an outside vendor to every AAUW member. Voting will begin on April 3rd, 2024 and will close on Wednesday, May 15th at 12:00 pm ET. Please check your membership profile at www.AAUW.org to make sure you can receive emails. If you have questions about what this means, check out this website: https://openupaauw.org.

AAUW Nevada Election: Election of the 2024-26FY Nevada Council will be held on Saturday, April 27th as part of our State Convention! If you have not yet registered for this incredible event, do it today! Your announcement for the April 27th Convention was sent via email the week of January 22nd. (Check your spam folder.) Check out Jennifer Verive's article about the importance of this convention later in this newsletter.

Nevada Primary Election – June 11th, 2024: This is a "closed" election meaning you receive a primary ballot based on your party registration. This election includes

candidates for Nevada legislative offices among others. Voting will include in-person as well as by mail.

Nevada General Election - November 5th, 2024: This is Presidential election day as well as for other specific Nevada legislative and county offices.

WHEW! What an exciting and very busy year ahead for all of us! Looking forward to a great year and YOUR involvement as AAUW members!

PUBLIC POLICY UPDATES

For anyone who missed it, there was an excellent Webinar given by AAUW National on January 31st titled Inclusion in Practice: How AAUW's Policies and Practices Promote Inclusion. I will give you some brief highlights below, but strongly recommend that if you have the time to spare, you visit the website to view it.

The highlights included: A review of AAUW

- Mission: Advancing gender equity through research, education, and advocacy.
- Vision: Equity for All.
- Values: Nonpartisan. Fact-based. Principled. Inclusive and Intersectional.

Discussion of the difference between Bylaws (Organizational Governing Documents - changes are voted on by the members - one member/one vote and Policies (approved by the Board of Directors).

Discussion of the **New Civility Policy and Members' Rights and Responsibilities,** which can be viewed on the website at https://www.aauw.org/resources/member/civility-matters. It was also included in an email to all members from our Board Chair, Julia T. Brown, Esq. on January 31, 2024. She points out that "As we approach another vote on open membership, creating respectful, courteous and inclusive environments is essential for us to achieve our mission, and AAUW members have a responsibility to demonstrate civility towards our collective AAUW community."

During the webinar, Edwina Martin provided some basic and appropriate skills to utilize when engaging in difficult conversations with those who have opinions other than your own. They include: be empathetic, be an active listener, visually show the person you are listening with gestures, body language that indicate engagement and understanding, be non-judgmental and non-condescending in your replies and comments, stay calm, respectfully agree to disagree, be patient, and attempt to find common ground.

We will have a challenging year ahead full of many controversial topics and areas, including but not limited to, the open membership vote, reproductive rights, Title IX rules, the ERA, and upcoming elections from local to national.

I encourage every member to strive to conduct themselves with civility and allow for a multitude of opinions on subjects. If you seek guidance on creating an inclusive space, there are many resources available on the national website by searching under DEI Toolkit.

Please remember that if you are ever a victim of bullying behavior at an AAUW event, please contact national to discuss your situation, and determine if a review is necessary.

Lastly, I would like to call your attention to upcoming events:

On February 28th, there will be a webinar at 7 pm EST, Evolution of AAUW, which will highlight our organizations' long history and how we have arrived at the present day.

March 8, 2024 is International Women's Day

AAUW Capital and AAUW Nevada Present An Evening with Nevada Supreme Court Justice Patricia Lee

Justice Lee joined the court in November 2022 when she was appointed by former Governor Sisolak. She will speak about women entering the field of law in Nevada and the issues most important to her, and offer insights related to Nevada cases about voting and the coming election.

AAUW NV 2024 Convention Sex Trafficking – Let's Get Informed and Answer the Call!

January is National Human Trafficking Awareness month. I didn't know that when I first started raising my own awareness about sex trafficking in preparation for organizing our 2024 AAUW Nevada Convention, **Spotlight on Sex Trafficking, Red Means Stop: Survivorship & Advocacy**. I was thankful when Caroline Punches, AAUW Nevada President, suggested we attend an event being held at the Governor's mansion in Carson City. The event was organized by Xquisite, a non-profit committed to "resourcing survivors to live a life that is filled with potential and propel them into their dreams."

The event included the reading of a proclamation by Governor Joe Lombardo declaring January 11 Human Trafficking Awareness Day with addresses by Attorney General Aaron Ford, Senator Catherine Cortez Masto, Senator Jacky Rosen, Nevada Senator Lisa Krasner, and Nevada Assemblywoman Angie Talyor. Brenda Sandquist, Xquite's Founder and Executive Director, and Tyson League, Supervising Deputy District Attorney for Carson City also spoke.

From these esteemed and passionate leaders, and my own research, I've learned:

- 73% of human trafficking cases involve sexual exploitation.
- 5,000 people are trafficked for sex online in Nevada *every* month.
- The average age of a sex trafficked survivor seeking help is 12 years old.
- Recent anti sex trafficking bills have been *unanimously* supported by both Democrats & Republicans in the Nevada legislature.

The relevance to our mission as AAUW Nevada members can't be clearer; the call to action is deafening. Indeed, AAUW National has issued a statement and Fact Sheet on Human Trafficking, which includes sex and labor trafficking:

"AAUW believes that global interdependence requires national and international policies against human trafficking and that promote peace, justice, human rights, sustainable development, and mutual security for all people."

Please join me at the AAUW Nevada 2024 Convention to learn more about the commercial sexual exploitation industry and trafficking – **Nevada has the largest commercial sex industry per capita in the U.S.** – and what it takes to help survivors get out of "the game" and reclaim their lives. And then to move beyond awareness, into action, to ally with survivors and advocate for the prevention of trafficking.

Fighting for equity and helping women live full and rich lives is what we AAUW members do best! I look forward to seeing you at this year's convention, where we are certain to be inspired by our keynote speaker, Annie Lobert, CEO and Founder of Pink Chair

MEET THE CONVENTION SPEAKERS!

AAUW Nevada has three wonderful speakers to help us get informed and answer the call!



Prior to voting for AAUW Nevada 2024 – 2026 state council officers and members, we're delighted to hear from Regent Carol Del Carlo. Also a Past President of AAUW Tahoe-Nevada, Regent Del Carlo will provide a brief update on the constitutional and legislative issues regarding the Board of Regents.

Next, we are grateful and honored to feature Annie Lobert, CEO and Founder of Pink Chair, as our Keynote Speaker. Annie will share her journey as a survivor of sex trafficking, raise awareness of the myths and facts of the sexual exploitation, and help us understand how we can advocate for and ally with survivors.

Annie Lobert, CEO & Founder, Pink Chair (Annie's bio from pinkchair.org)

Annie Lobert is a survivor. Annie experienced more than a decade of sex trafficking in Hawaii, Minneapolis and Las Vegas. She has been working with survivors of trafficking for more than 20 years.

From her own personal experience, Annie is an internationally recognized expert and advocate of ministry to those who have been sex trafficked and commercially exploited. She fully understands the traumatic psychological, emotional and physical effects of initially choosing the sex industry as a job choice only later to be trapped, beaten and sold to the sex trafficker's highest bidders. She is also a survivor of Complex Post-Traumatic Stress Disorder (CPTSD), domestic violence, sexual abuse, cancer, drug addiction, abortions, miscarriages, pornography, anorexia and bulimia.



We'll wrap up by hearing from Eliza McCoy, VP of Awareness and Prevention Programs for the American Hospitality and Lodging Association (AHLA) Foundation about how the Hospitality Industry is preventing sex trafficking in hotels and motels across the country, and their new grant fund to support survivors.







From the Boulder City Branch:

Michael met with Power Point Manager of the Conference Room prior to his presentation to make sure the AV equipment worked with his device. 





